Information notice on the processing of personal data (Art. 13 of Leg. Decree 196/2003)

Interested persons: recipients of the newsletter.

IFI S.P.A. in its capacity as the Processing Owner of your personal data, pursuant to and for the purposes of Leg. Decree no. 196 of 30 June 2003 ('Code covering the protection of personal data', hereinafter the 'Privacy Code'), hereby informs you that the above-mentioned regulation governs the protection of persons and other entities regarding the processing of personal data and that such processing will be conducted on the basis of the principles of accuracy, lawfulness, transparency and protection of your confidentiality and of your rights.

Your personal data will be processed in accordance with the provisions of the above-mentioned regulation and the confidentiality obligations contained therein.

In addition your personal data may, subject to your consent, be used for the following purposes:

- Sending of the information requested.

While the provision of the data is optional for the purposes indicated above, refusal of processing on your part may compromise the continuation of the relationship.

Processing methods: your personal data may be processed in the following ways:

- Processing by means of electronic equipment;
- Manual processing by means of paper archives.

All processing is in accordance with the methods set out in Articles 11, 31 *et seq.* of the Privacy Code and by means of the adoption of the minimum security measures set out in the technical specifications (Appendix B).

Communication: your data will be held in our head office and will be communicated solely to the persons competent to carry out the services necessary for the correct management of the relationship, with the guaranteed protection of the rights of those interested.

Your data will be processed only by the Owner's expressly authorised personnel and, in particular, by the following categories of responsible persons:

- General management;
- Management Secretariat;
- Hotels Backoffice.

Broadcasting: your personal data will not be broadcast in any form.

Owner: the Owner of the data processing pursuant to the Law is IFI S.p.A. (via Perathoner 10, 39100 Bolzano (BZ); email: info@ifigroup.it; telephone: +39 0471 312500) in the person of its *pro tempore* legal representative.

Managers: the managers responsible for the processing of your personal data are:

You have the right to obtain from the managers the deletion, communication, updating, correction and completion of the personal data concerning you, and you may in general terms exercise all of the rights set forth in Art.7 of the Privacy Code provided in copy form below.

Legislative Decree no. 196/2003: Art. 7 – Right of access to personal data and other rights

1. The interested party has the right to obtain confirmation of the existence or otherwise of personal data referring to it, even if not yet recorded, and its communication in intelligible form.

2. The interested party has the right to be informed of:

- a) the origin of the personal data;
- b) the purposes and methods of processing;
- c) the techniques applied where processing is by means of electronic tools;
- d) the identification of the owner, the managers and the designated representative pursuant to Article 5, subparagraph 2;
- e) the persons or categories of persons to which the personal data may be communicated or to whose attention it may come in their capacity of designated representative for the territory of the country, of managers or of responsible persons.

3. The interested party has the right to obtain:

- a) the updating, correction or, where relevant, the completion of the data;
- b) the deletion, anonymisation or blocking of data processed in breach of the law, including data whose holding is not necessary for the purposes for which the data has been gathered or subsequently processed;

c) an attestation that the operations referred to under a) and b) have been brought, including as regards their content, to the attention of those persons to which the data has been communicated or broadcast, with the exception of cases where this is not possible or would involve the use of resources that are manifestly disproportionate to the right being protected.

4. The interested party has the right to oppose, in whole or in part:

- a) the processing of the personal data concerning it on legitimate grounds, even if pertinent to the purpose of the gathering;
- b) the processing of personal data concerning it for the purposes of dispatching advertising material or direct sales or for commercial communication or market research purposes.
